New Local Schools

MANY OF OUR CHILDREN will soon be attending new or refurbished schools in the constituency thanks to the increase in Government funds.

New schools, fit for the 21st century, include Valley Park, Norton Free and a replacement for Bluestones and Norfolk Schools. Lower Meadow has a new extension and there are also plans for replacements at Woodthorpe, Arbourthorne and Anns Grove. It is many, many years since we have seen such a large investment in our schools.

Education has also remained one of Meg's priorities as a member of the Education and Skills Select Committee. Whilst on the Committee she has over the past year investigated topics such as student tuition fees, a new curriculum in secondary schools and the creation of more specialist schools. In June Meg was appointed as Parliamentary Private Secretary to the Department for Education and Skills. She is delighted to be able to work with Ministers to continue the improvement of our children's education.

Fair Trade Can Make A Difference

MEG SHARED a cup of coffee and some campaign ideas with Oxfam recently.

As part of their Make Trade Fair campaign, Oxfam is concentrating in particular on the crisis in the world coffee industry where massive overproduction has pushed prices down to an all-time low. 25 million coffee producers face ruin. The four giant coffee companies make huge profits while paying coffee farmers less than it costs to grow it.

Speaking at a special Oxfam Coffee Morning, Meg Munn, who always buys Fair Trade coffee, said "In coffee growing countries, if there is no revenue from sales of coffee beans then there is no money to send children to school or to buy medicines. Buying basic foodstuffs is becoming a problem for coffee growers now. It is difficult for ordinary people in the West to feel that they can make a difference to situations like this but buying Fair Trade goods is one way in which everyone can get involved."

Hard-working Specials Rewarded

IN FEBRUARY Meg was delighted to be asked to present certificates to hard-working Sheffield Specials recognising the hours they have put in.



Meg presented Chief Officer Alan Richards and Special Constable Sarah Murdoch with certificates commemorating 985 hours of service by Special Constables in the last 6 months of 2002, 264 of those by Sarah herself.

Alan told Meg that his team 'deal with all sorts of things from lost children to sudden deaths. One Special Constable recently caught and arrested a burglar while he was actually breaking into somewhere, and stayed with the case until the burglar came to court, where he asked for a further 20 cases to be taken into consideration. The role might be unpaid but the officers are working just as hard and on a wide range of things.'

Tap-dancing for Macmillan Cancer Relief



Meg took part in the Macmillan Cancer Relief Parliamentary Palace of Varieties, in January, tap dancing, with a small group of other women MPs who call themselves the Division Belles, raising money for this important charity.

Adopting New Ideas

AS A FORMER SOCIAL WORKER in children's services, Meg strongly supported changes to the law which now allow unmarried couples to be considered as adoptive parents. Previously legislation allowed single people and married couples to adopt but not unmarried couples.

All adults applying to be adopters are subject to rigorous assessment to ensure that they can meet a child's

needs. This is the most important issue, not whether they comply with an idealised view of a family.

Crucially there are many more children needing families than there are adopters. It's a shocking fact that a boy over the age of 5 is very unlikely to find someone to give him a permanent home. These new measures will give all of our children a much better chance of finding a family.

Animal Cruelty Must Be Stopped!

MEG HAS ADDED HER SUPPORT to a campaign to increase the penalties for illegally trading in wildlife right here in the UK.



'We think of ourselves as a nation of animal-lovers but this campaign has exposed double standards in our laws. A person can be arrested for selling a common frog, which is a protected UK species, but can't be arrested for selling a tiger or rhino – some of the world's rarest species. They can be charged and taken to court, but because selling tigers is not an "arrestable offence" the police cannot take a suspect into the police station for questioning and find out where the animal came from or how it was obtained.

The law needs to be strengthened, giving it stiffer penalties and making offences arrestable to help Police stop this scandalous trade.'

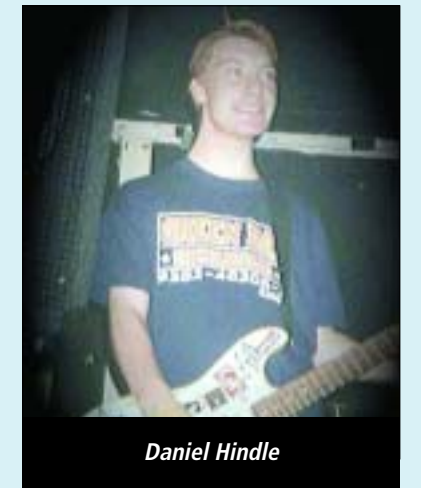
Building Links with Small Business

Hidden Dangers

PROMISING MUSICIAN Daniel Hindle, 17, died in December last year of septicaemia - two months after he visited a Sheffield studio to have a ring fitted to his lip.

The A-level student, who had battled against a potentially fatal heart condition since birth, fell ill just days after the piercing.

Since being contacted by Daniel's mum, Christina, Meg has been fighting for a change in the law to regulate piercing studios and for a public health campaign on the potential dangers of body piercing.
